INTRODUCTION

Hartlepool Sportability Club is committed to providing a safe, inclusive, and enjoyable sporting environment for all members, volunteers, coaches, and visitors. This Code of Conduct outlines the standards of behaviour expected by everyone involved with the club, whether taking part in activities, spectating, volunteering, or representing the club in any capacity.

By becoming a member, coach, or volunteer, you agree to follow this Code and uphold the values of **respect, inclusion, teamwork, and fairness**.

GENERAL CONDUCT

All individuals associated with Hartlepool Sportability Club are expected to:

- Treat others with **dignity, respect, and kindness**, regardless of age, ability, gender, race, religion, or background.
- Demonstrate **sportsmanship**, both in victory and defeat.
- Support and encourage fellow members to reach their potential.
- Take pride in the club's positive reputation and act responsibly at all times.
- Follow instructions from coaches and volunteers for health, safety, and wellbeing.

MEMBERS

Members are expected to:

- Arrive on time for sessions and take part to the best of their ability.
- Respect the rights, dignity, and worth of all participants.
- Avoid using language or behaviour that is abusive, threatening, or discriminatory.
- Report any concerns or unsafe behaviour to a coach or committee member.
- Adhere to all safety rules, including appropriate dress and footwear.

Look after club equipment and facilities.

COACHES AND VOLUNTEERS

Coaches and volunteers are expected to:

- Act as **positive role models** and uphold the highest standards of conduct.
- Maintain appropriate boundaries with all members.
- Hold relevant qualifications and keep safeguarding and first aid training up to date.
- Prioritise the welfare and wellbeing of participants at all times.
- Communicate clearly, calmly, and respectfully.
- Encourage enjoyment and participation, not just performance.
- Challenge poor behaviour or discrimination immediately and report it where necessary.

PARENTS, GUARDIANS, AND CARERS

Parents, guardians, and carers are expected to:

- Encourage and support participation in a positive way.
- Ensure members attend sessions on time and are collected promptly.
- Inform coaches or staff of any medical or support needs.
- Refrain from negative or disruptive behaviour during sessions.
- Respect decisions made by coaches and officials.

SAFEGUARDING AND EQUALITY

The club is committed to creating a safe environment for all.
